CURRENT REPORT

The volume of sales outside the PGNiG Group includes sales of the following companies: PGNiG SA. PGNiG Sales & Trading and PGNiG Obrót Detaliczny.

As at September 30th 2017 PGNiG's stocks of gas (including mandatory stocks managed by the Minister of Energy) stored in underground high-methane gas storage facilities was approx. 2.9 billion cubic meters. This volume of gas stocks does not include the volume managed by Operator Systemu Przesyłowego GAZ-SYSTEM SA.

The above data are estimates and may differ from the actual data. due to be disclosed on November 8th 2017 with the publication of the interim report.
